# McEldowney Takes First in Oratory Contest

With a clever introduction and verbal illustrations drawn from personal experience helping teens in crisis pregnancies, Chloe McEldowney, a senior at Russia High School, received top honors for her speech at the Pro-Life Oratory Contest sponsored by Right to Life of Shelby County on February 25 at St. John's Lutheran Church in Sidney.

Nine juniors and seniors participated in the contest, speaking on topics ranging from the biological beginning of human life at conception to unjustifiable decisions to

In April, McEldowney will compete at the statewide Ohio Pro-Life Oratory Contest, in Westerville, Ohio, with the chance to proceed to the national contest in June.

In McEldowney's exhortation, she admitted that helping people make lifeaffirming choices often requires enduring opposition and trials, which, at times, is like enduring a terrible stench. But, she said, "I am so happy that my family and I are able to reach out and help each of these young mothers and their babies. There is no stench in this world that would make me want to stop supporting life in this way." Continued on page 2

# Members Moved, Encouraged by Speakers

The Alpha Center in Sidney was the scene of Shelby County Right to Life's Membership Meeting, Friday, March 12. The event, open to all members of RTL, featured presentations by local members and representatives of Ohio Right to Life, based in Columbus.

Sidney teen and 2009 National Right to Life Oratory Contest champion, Elizabeth Trisler, opened the program with a presentation of her awardwinning speech, followed by a summary of her experience as the national winner. Area nurse Michelle Dieperink offered a moving testimony of her own experience of abortion, stressing that its negative effects are longlasting.

Gillian Stechshulte and Elyse Putnam, outreach and media officers at Ohio Right to Life, updated the county group on state-level activities and explained the importance of membership in right to life organizations.

Board member Mary Schmiesing offered a brief history of Shelby County RTL. "It began as all great movements do," she quipped, "around a kitchen table." The program closed with a summary of the organization's accomplishments in 2009: 1800 visitors to RTL's downtown thrift shop; 25 individuals referred to the Sidney Women's Center; and 200 students and adults reached through educational programs.

Member John O'Neill commented, "It was wonderful to see the right-to-life people of Shelby County come together to meet and to share their stories," he said. He said he was "amazed at the impact that people from Shelby County have had on a national level."

## **Health Care Bill Funds Abortion**

Following is a statement from National Right to Life concerning the health care bill recently passed by Congress. There are a number of petitions and calls for other forms of protest circulating. We leave it to members to determine which method of action they



deem most appropriate and effective. Most importantly, this development demonstrates the imperative of electing consistently pro-life legislators who will not compromise the defense of unborn human life, in particular. Calling oneself "pro-life" is not good enough: one has to be willing to stand against one's own political party and any other political pressures, if necessary. We need to keep this principle in mind as we decide whom to support and vote for in the primaries this spring and in the general election this fall.

Statement of National Right to Life, Sunday, March 21

The National Right to Life Committee (NRLC) remains strongly opposed to the Senate-passed health bill (H.R. 3590). A lawmaker who votes for this bill is voting to require federal agencies to subsidize and administer health plans that will pay for elective abortion, and voting to undermine longstanding pro-life policies in other ways as well. Pro-life citizens nationwide know that this is a pro-abortion bill. Pro-life citizens know, and they will be reminded again and again, which lawmakers deserve their gratitude for voting against this pro-abortion legislation.

The executive order promised by President Obama was issued for political effect. It changes nothing. It does not correct any of the serious pro-abortion provisions in the bill. The president cannot amend a bill by issuing an order, and the federal courts will enforce what the law says.

To elaborate: The order does not truly correct any of the seven objectionable pro-abortion provisions described in NRLC's March 19 letter to the House of Representatives, which is posted here: www.nrlc.org/AHC/NRLCToHouseOnHealthBill.pdf. Regarding Community Health Centers (CHCs), NRLC has documented the problem created by H.R. 3590 here: www.nrlc.org/AHC/NRLCMemoCommHealth.html.

Prof. Robert Destro, a professor of law and former dean of the Columbus School of Law at the Catholic University of America, and an expert on abortion-related litigation, has sent lawmakers a letter explaining why the bill opens the door to direct federal funding of abortion in Community Health Centers: www.nrlc.org/ahc/DestroLetterToStupakOnCommHealthCenters.pdf. Prof. Destro clearly explains why it is the statutory language that will govern.

Regarding the new program to provide tax credits to purchase private insurance, the executive order merely tinkers with the formalities of a bookkeeping scheme under which federal subsidies will pay for plans that cover elective abortion—a break from the longstanding principles of the Hyde Amendment.

The order does nothing at all to mitigate the other abortion-related problems described in the NRLC letter, dealing with bill provisions that create dangerous regulatory mandate authorities, revise Indian health programs, and create pools of directly appropriated funds that are not covered by existing restrictions on funding of abortion. Nor can the order correct the omission from the pending legislation of the necessary conscience-protection language that had been included in House-passed health care legislation last November (the "Weldon language").
