## Sehlhorst Takes Top Honors at Oratory Contest

At the end of the judges' deliberation over six excellent speeches, Lehman Catholic senior Daniel Sehlhorst was awarded first place and \$300 at the annual Shelby County regional Pro-Life Oratory Contest, held February 20 at St. John's Lutheran Church in Sidney.

The contest, which is open to students from any school in Shelby County, had participants from Christian Academy, Sidney High School and Lehman Catholic. The objective of each contestant was to present an argument intended to convince the audience of the dignity of all human beings—from conception to natural death—and of their inherent right to be protected from intentional killing. The scoring of the contest was strongly weighted on the prepared speech, with oral presentation accounting for only one fourth of the score.

The orators were judged on presentation, organization and content, including use of current and accurate facts and affirmation of the value of human life in all stages of development. Continued on page 2

## Religious Leaders Continue to Fight HHS Mandate

Family Research Council President Tony Perkins led a news conference today during which he unveiled a new letter signed by more than 2,500 Catholic, evangelical, Protestant, Jewish and other religious leaders opposing the new Obamacare mandate.

The leaders are urging President Obama to reverse his mandate decision and protect the conscience rights of those who have moral and religious opposition to funding or providing contraceptives and abortifacients.

"It took just three weeks, but every single Catholic Bishop in America has officially condemned the President's mandate. Even though the media has mostly buried this fact, one hundred percent of them oppose the rule that orders faith-based groups to pay for drugs that destroy pregnancies or prevent them. It's a formidable group, and today, they do not stand alone," Perkins said. "Every pocket of religious America is linking arms at the front lines of this war on religious freedom."

Perkins continued, "No church should be forced to concede their faith to kneel at the altar of government. And until the administration rights this wrong, we unite with our allies in diverse faith traditions in demanding what George Washington called "the invaluable rights of free citizens." Perkins was joined by Dr. Richard Land, President, Southern Baptist Convention's Ethics & Religious Liberty Commission and Bishop Harry Jackson, Senior Pastor, Hope Christian Church in unveiling the letter. ## Religious, Pro-Life Groups Fight Obamacare Mandate Continued from page 1

The unveiling of the letter comes as Obama faces two additional lawsuits over the controversial mandate. Meanwhile, more than a dozen state attorneys general have signed onto a joint letter Nebraska Attorney General Jon Bruning started coordinating against the controversial Obama mandate requiring religious employers to cover birth control and drugs that can cause abortions.

Congressman Jeff Fortenberry held a press conference with supporters of the bipartisan, bicameral Respect for Rights of Conscience Act. His legislation would protect the religious liberty and conscience rights of every American who objects to being forced by the strong-arm of government to pay for drugs and procedures recently mandated by the Department of Health and Human Services (HHS).

The Fortenberry bill currently has the support of approximately 220 Members of Congress and Senators, the most strongly-supported legislative remedy to the controversial HHS mandate. This measure would repeal the controversial mandate, amending the 2010 health care law to preserve conscience rights for religious institutions, health care providers, and small businesses who pay for health care coverage. H.R. 1179 enjoys the endorsements of the United States Conference of Catholic Bishops, National Right to Life Committee, Americans United for Life, and other organizations. Numerous other organizations, including the Christian Medical Association and Family Research Council, have urged support of the bill.

The administration initially approved a recommendation from the Institute of Medicine (IOM), suggesting that it force insurance companies to pay for birth control and drugs that can cause abortions, under the Obamacare government-run health care program. The companies will likely pass the added costs on to consumers, requiring them to pay for contraception and abortifacient drugs. The HHS accepted the guidelines from the IOM, which advises the federal government and had shut out pro-life groups in meetings leading up to the recommendations .

Only those candidates involved in contested primaries were contacted. Questionnaires are a tool, but have their limitations. We encourage you to contact candidates directly for further information. At the national level, although Jim Jordan’s congressional district has changed, all of Shelby County remains in his 4th Congressional district.

At the state level, Ohio RTL PAC has endorsed Josh Mandel for the U. S. Senate because he is the pro-life candidate that they believe has the best chance of winning in the general election.

At the state level, the 85th district represented by John Adams which formerly included all of Shelby County has been split. The following townships and municipalities will remain in the 85th House district: Clinton, Franklin, Green, Lockington, Orange, Perry, Port Jefferson, Salem, Sidney, Washington. The rest of the county will be in the 84th district for this election. (There is no primary contest in the 84th.) Contact the Board of Elections if you need further information.
