Ohio Pro-Life Law Now in Effect

Ohio's new Protecting Pregnant Women from Coercion and Violence Act went into effect in April. In addition to protecting pregnant women from violence and coerced abortions, the new law allows individuals to seek damages by offering proof against abortion facilities demonstrating a pattern of failing to report known or suspected child sexual abuse.

The Ohio Supreme Court has noted this new provision in a recent case. The new law, sponsored by former Rep. Michelle Schneider:

- Requires abortion facilities to post a "No One Can Force You to Have an Abortion" poster;
- Requires mandatory minimum prison sentences for assault and increases penalties for domestic violence if the offender knew the victim was pregnant;
- Permits recovery of compensatory and exemplary damages in a civil action for failure to file required reports of known or suspected child abuse;

White House Staffer: More Than Two Million Red Envelopes Deluge President

A White House mailroom staffer has confirmed that nearly 2.5 million red envelopes have made their way to President Barack Obama to protest his pro-abortion record. The staff member says the campaign is one of the largest efforts he can recall in his 35 years working at the White House.

The mailroom worker, identified in a WorldNetDaily interview as Steve, helps oversee the mail destined for the president. Asked if he had seen a deluge of red envelopes in recent weeks, Steve responded: "Uh, yes. Believe me, they made it here. Quite frankly, there was definitely a deluge of mail coming through," he laughed. "I had to handle them all."



Though President Obama is in Europe on a foreign trip, the White House worker said the Obama administration has noticed the flood of red envelopes against abortion. "I've been here 35 years, so I've seen presidents come and go," he told WND. "This campaign ranks up there with the big ones."

Inspired during a prayer, Massachusetts resident Chris Otto came up with the idea of sending red envelopes to President Barack Obama to protest his pro-abortion policies. As he told LifeNews.com back in February, what started out as an email request to 120 of his ministry friends and supporters turned into a nationwide phenomenon that saw others ask pro-life advocates to coordinate sending their red envelopes to Obama this week.

"We are trying to change the president's heart," Otto says. "This is a message to a man that God hears the cry of innocent blood. It is not a political stunt, although I hope it changes policy in Washington."

A Texas man named Brian Potter set March 31 as the date for sending the red envelopes and that coordination appeared evident in the comments from the White House mailroom employee. Several web sites have been set up in support of the project and the people who have responded saying they sent or will send envelopes has reached over 1.5 million, though not everyone has registered with the web sites.

"For me, this has been a living parable of my philosophy of life and ministry: 'Listen to the Lord, and do what He tells you," Otto tells LifeNews.com. "I was not expecting such a dramatic outcome."

• Provides mandatory prison sentences and payment of restitution to victims in cases of "human trafficking" for prostitution.

Recently, the Ohio Supreme Court issued an order directing the parties in Roe v. Planned Parenthood Southwest Ohio Region to file briefs addressing whether the provisions of the new law apply to the case. The case was brought by Cincinnati-area parents whose minor daughter had an abortion at a Planned Parenthood facility without her parents' knowledge after being sexually abused by her adult coach. The parents allege that Planned Parenthood failed to comply with the statute requiring reports of known or suspected child abuse as well as Ohio's parental consent statute.

"We are proud that Ohio has acted to protect women and children from coercion and abuse," said Mike Gonidakis, President of Ohio Right to Life. "Coerced abortion, violence against pregnant women, and child abuse have no place in a civilized society," Gonidakis said.

Planned Parenthood Boycott List Now Available

Many who value life are rightly concerned to support only companies that do not contribute to the abortion industry, pro-euthanasia groups, or other anti-life entities. Life Decisions International (LDI) is a Virginia-based organization that monitors the corporate supporters of Planned Parenthood. RTL has purchased The Boycott List from LDI. Because of copyright restrictions, we cannot copy or distribute the list, but members of RTL may view the list at the office. (The copyright restrictions are of particular concern because of LDI's interest in disseminating only current and accurate information to the public.) The list is considered valid through July 2009. Included on the list of corporate contributors to Planned Parenthood are Levi, Merck, Warner Brothers, Johnson & Johnson, and Holiday Inn, among many others. Those interested in participating in either a boycott or a letter-writing campaign to these companies, may visit the RTL office and ask to see The Boycott List.

Prayer Chain for Pregnant Mothers

We should all be praying constantly for greater respect for life. For those who feel a more specific prayer calling, you might consider signing up for RTL's prayer chain.

The prayer chain requests are generated from the Women's Center in Sidney. Whenever staff there believes that a woman who has visited or contacted their office is still planning to get an abortion after they have done all they can to convince her otherwise, they call our prayer chain coordinator. Those who sign up on our prayer chain will be sent an e-mail with "prayer request" in the subject line, asking for prayers for the woman and her unborn child. To maintain confidentiality, no name or other identifying information is given, but you will be praying for a specific mother and child in need at that time.
